





Where were you at the time of the District 20 Change of Watch? ***If you were at the Elgin Holiday Inn, you can skim my message below.*** I say skim to refresh your memory, and repeat soliciting your input in the district's (your) program. ***If you didn't attend the COW, then I urge you to read below*** to determine how best to work the district's (your) program to your squadron's advantage. You'll note the interjection of the word "your" when referring to the district's program. That's intentional.

Here's the highlights of that inaugural COW message:

- ◆ Initially I asked for membership input. If you have an idea, a name, an activity or a location, let it be known. Ours is a program for boaters by boaters.
- ◆ I will support activities reasonably convenient to all squadrons. I realize the reluctance to travel to participate in district activities, especially when weather is bad.
- ◆ Find somebody to mentor. Find someone in your squadron to prod, cajole, accommodate, and have fun with. Your leadership problems will be minimized.

MERIT MARKS

Are you keeping accurate squadron records? Certainly I'm premature raising the question, but the November deadline comes too quickly.

Also I am aware of the opportunities of rewarding merit marks lies before us.

Just keep a record of who, what and how much time was involved. They're USPS's reward for valuable service.

Wear them proudly!

At our April bridge meeting I urged officers to visit squadrons other than their own. There's a need to see the connection between squadron and district. District is the conduit for USPS national. District bridge visits are intended to strengthen the bond between the two levels. Squadron commanders if you don't get a request for a visit, let me know. We're visiting to observe, assist if necessary, and to encourage participation in district and national activities. Just allow for mutual scheduling.

USPS National is making changes with the speed of a cigarette boat! The entire educational program is taking on a new face. See DEO Theresa Phillips'

comments in this issue. I'm of the opinion classroom instruction is a thing of the past. Almost all educational offerings are electronic. D/Lt/C Phillips, P has a power point program detailing educational changes. It was part of the D/20 COW. Invite her to your meeting. At the least ask Teri to make a copy available to your squadron. S, P, AP, JN, and N are things of the past.

Have you accessed the new Educational Completion Certificate? USPS National will not be sending out educational course completion stickers for the old membership certificates. Yes, another change. Have your USPS PIN available to access.

New certificates can be accessed by SEOs and squadron commanders as well as members. 1. Visit USPS.Org. 2. Go to the "site index," and 3. select the "information center." For the information center menu click on the icon (blue dot at the top of the page). The menu pops up on the left. 4. Scroll to "My Information", and then 5. click on "My Training History". Try it. It's an impressive document!

I concluded my inaugural message with a tribute to my late, dear friend P/D/C Richard N. Spurr, SN. Without Dick's mentoring I wouldn't be your district commander. He was always there for me, especially regarding USPS business. I repeat, find somebody to mentor.


It is my wish that this year's bridge can contribute to and make a difference to the success of each of the district's squadrons. I will do my part to make it happen!

A big thanks to P/D/C Mike Ludtke for instructing 11 students in Vessel Safety classes—all done on-line. I appreciate the effort. Thanks to those students also. National sent out the following suggestions for VE’s to handle the Kidde extinguisher recall:

When performing a vessel exam on a boat equipped with a possibly recalled KIDDE fire extinguisher aboard, advise the owner/operator to read the information below and take appropriate action. In addition, vessel examiners should mark “RECALL” in the margin of the fire extinguisher block on form ANSC 7012 and make the owner/operator aware of your notation. You might even print the information yourselves and give it to the boater.

“Walter Kidde has issued a recall of certain fire extinguishers manufactured between Jan. 1973 and Aug. 2017. All of the extinguishers had plastic handles; were

sold in red, white and silver cylinder colors; and are rated as either ABC or BC. To find out if you have a recalled extinguisher and how to obtain a replacement, go to the *Kidde.com—click support then Product Alerts* for the full notice.”



Greetings! The Spring Conference in Elgin was a good time. If you missed it the reports are on Sail Angle under 2018 Spring Conference. There was much information presented, and of course, some story swapping in the hospitality rooms.

Chapman Award for 2018

It is time to think about putting information together to nominate from your squadron a Chapman Award winner. There are new instructions and forms for the program for the July 1, 2017 – June 30, 2018 Educational year. The instructions and forms are different from previous years due to feedback received in 2017. The forms and instructions will be posted on the Awards page, and squadron education officers and commanders will be notified by National headquarters when this occurs.

America's Boating Club Marketing Guidebook Update

During the SEO presentation, I mentioned the Marketing Guidebook. There is lots of information on invigorating and modernizing your squadrons marketing approach, as well as helping recruit new members. Instructor Development Recertification Class

The recertification class that was presented at the Spring Conference is now available for download. Anyone who has ever been a certified instructor, even if not currently active, can get recertified by taking this course. It focuses on presentation skills useful in any kind of presentation. Helpful in a leadership role or as a member providing a program for a membership meeting.

Look for update to Celestial Tools on ONCom Software and Tools web page. The update included a couple of bug fixes, and the ability to include a zone description for a Favorite Places location. The enhancement is handy if the location's civil time zone does not conform to the standard 15-degree bands of longitude.

Advanced Grades Curriculum

More descriptive course names on all advanced grade courses are being updated. This is to reflect the course content better. The changes are as follows:

- Seamanship becomes Boat Handling
- Piloting becomes Marine Navigation
- Advanced Piloting becomes Advanced Marine Navigation
- Junior navigation becomes Offshore Navigation
- Navigation becomes Celestial navigation

Each course will be adopting a seminar series format. By the end of 2018, the Boat Handling seminar will be completed.

Upcoming

The 2018 Governing Board Meeting is August 15-19, 2018 in Minneapolis, Minnesota. It's close enough to attend, and there are many sessions with plenty of information that can help out squadron officers and members.

District 20 events are still being planned as of this writing, but include Cruise & Rendezvous and Fall Conference. Not only are they social occasions, but informative. Keep looking for updates.



Heritage Harbor/Ottawa, Illinois, is preparing for the arrival of District 20's Cruise & Rendezvous July 28. It's an occasion not to be missed!

Centrally located in Illinois, less than two hour's drive from any of the state's squadrons, Heritage Harbor has amenities which will please and delight D/20's membership. All members are encouraged to participate.

Located 2 and half miles southwest of the intersection of I-80 and Illinois 71, Heritage Harbor is nicely appointed, but is a work in progress. Harbormaster Jeremy Fowler has promised to meet the needs of USPS District 20. Its' website is HeritageHarborOttawa.com. Access it for additional details.

Heritage Harbor is a sprawling recreational development on the Illinois River. District 20 will be meeting in the BLUE ROOFED pavilion in the harbor. The blue roof is an important landmark.

After exiting I-80 and driving southwest on Illinois 71, be alert to catch Canal Road across from the Bill Walsh GM Dealership. Look for N2871 St. rd., cross the tracks and turn left on to county rt 51/2753 rd. (not same as US 51). SE on 2753 rd., Heritage Harbor will be on the right. The use of a GPS is advisable.

The exact address of our rendezvous is 1970 N. 2753rd Road, Ottawa. Pass up the first entrance sign to Heritage Harbor and continue another half mile to the main entrance to the resort. Signage is clear after that.

Park in the lot adjacent to the Red Dog Restaurant or as directed by marina staff. Harbormaster Fowler has

promised the use of a golf cart to transport membership to the harbor-level pavilion. Breakfast is available at the Red Dog for those arriving early.

The C & R schedule is as follows:

- 1000 -- 1100: Presentation by Pat Antoni, SN, on the use of Sail Angle and DB2000.
- 1100 -- 1230: Council Meeting.
- 1230: Pig Roast. Cost \$15 per person. Soft drinks included. Please phone D/Lt/C Ken Crutcher, AP, (773-575-8177), and/or email Ken at kencrutcher@ymail.com with squadron participation by July 23. Want to have enough pig for everyone!
- 1400 – Thereafter: Vessel Safety Checks in harbor. Harbormaster Fowler will promote. VEs bring your forms and stickers!
- 1400— Thereafter: Recreating in harbor or on Illinois River. Rental boats available by contacting Fowler's staff at 815-434-5001. Use of launch ramp for personal craft free.
- 1400 – Thereafter: Visiting historic Ottawa and LaSalle, IL, or nearby Starved Rock State Park.

Those wishing to stay overnight, rental facilities are available at the resort. The rental homes easily sleep 2 families, and are priced at a minimum of two night's stay. Call harbor staff for rates. Other accommodations are available in LaSalle County, and/or at the Starved Rock State Park lodge.







SECRETARY’S REPORT


One of my primary activities, besides note-taking, is to maintain a complete roster of bridge officers for the District and all Squadrons within. I am using the data extracted from National (DB2000), where the data may not match exactly with what we currently have on file. If your data at National does not contain what it should (wrong phone numbers, email addresses, etc.), please update your profile with National and send it to me as well. Be sure the squadron officer form reflects your current bridge. Your commander, secretary or roster chair can check that by clicking on “forms” in DB2000 and selecting OD-2 (for squadrons). If it is not correct, make the changes and upload to national. For individuals, go to the USPS.org website and click on “Manage Profile”. This will automatically update in DB2000.

It appears there was a problem at national. They collected the money when the dues invoice was sent out, but decided they were not authorized to accept this money from each member...and refunded it back to the squadrons.


Unfortunately, it was not flagged and your treasurer deposited it into each of your treasuries.


The department luncheons are open to all committee members—Squadron, District and National who serve in the specific departments.

- Posters must not be folded.

- Only one entry per person is allowed. All entries become the property of the United States Power Squadrons, which reserves the right to display and reproduce.
- Contest entry forms must be complete, legible, and attached to the back of their poster.


